«Center for missing & exploited children» works more than 17 years all over Ukraine. In 2018 for large-scale public information there were created information content and disseminated in mass-media, that supports us pro bono: 36 TV-channels, 5 printed media, 5 networks of outdoor advertising agencies and indoor TV. Thanks to technical partners support, hot-line 116 000 is available - calls for subscribers of all mobile operators are free of charge.

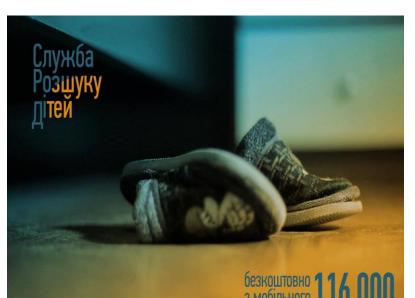
Types of consultations on hot-line





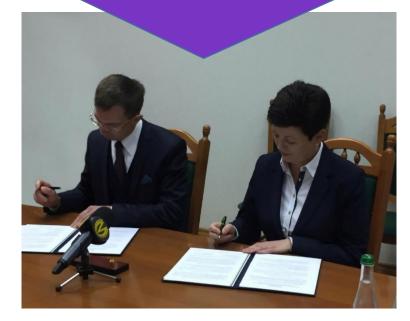

## ADVOCACY

Memorandum on Cooperation was signed with the Ministry of Foreign Affairs of Ukraine. The main objective of the Memorandum is to consolidate efforts to increase protection of Ukrainian citizens in case of their children disappearance abroad.



Participation in the Coordinating Council on the observance of the rights of children and families under the Ombudsperson of Verkhovna Rada of Ukraine. Participation in the meeting «Implementation of the National Strategy for Reforming of the Institutional Care and Children Upbringing for 2017-2026, approved by the Cabinet of Ministers of Ukraine on 09.08.2017, No 526-p»



Participation in an expert meeting of the Ministry of Justice of Ukraine and representatives of the mediator community on cross-border family mediation in cases of international parental abductions.

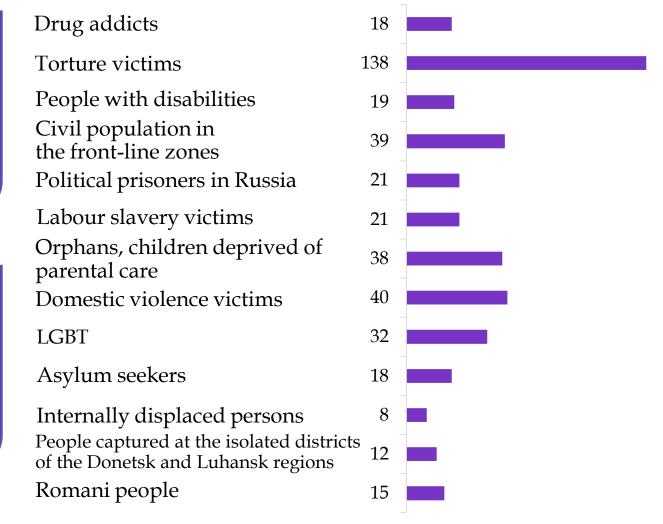

## INFORMATIONAL AND EDUCATIONAL ACTIVITIES

The activities is aimed to increasing public awareness on the rights of vulnerable groups, increasing level of tolerance to vulnerable groups and enhancing the credibility of human rights defenders.

During 2018 we have created 419 media materials, that was broadcasted in mass media.

There were involved 94 human rights defenders during creation of media materials.

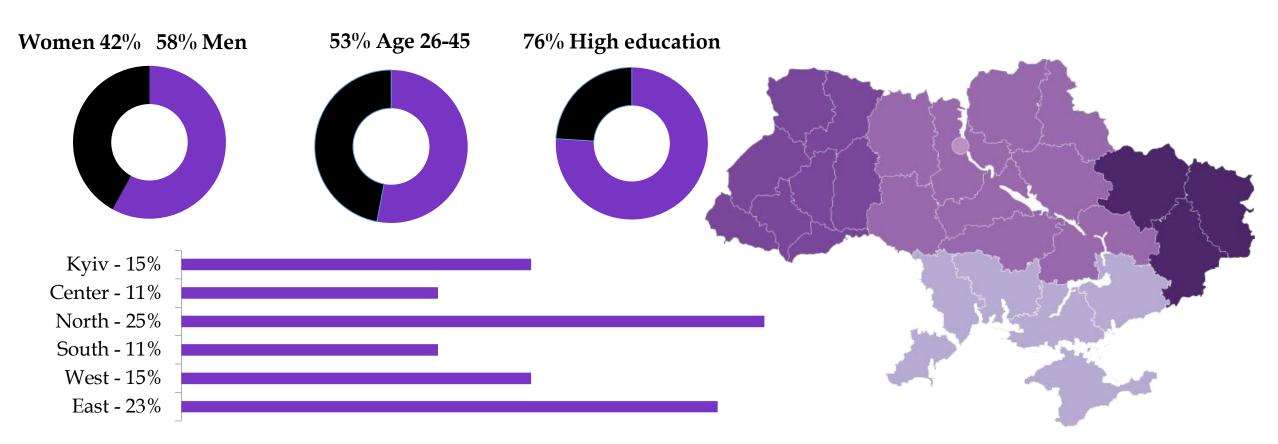

## PROJECT: «Recruting Patronage Families in Ukraine»

#### 01.01.2018 - 30.08.2018

**GOAL**: to recruit potential candidates for the programme of Family Patronage Services, thereby decreasing the number of children who are placed in institutional care.



**RESULT**: 282 free consultations were provided on hotline by consultants. 78 potential patronage families were redirected to local social services.

**PARTNERS**: LLC «Magnolia-TV», the Partnership for Every Child, TV-channel «ChP.INFO». The project was implemented with financial support of the World Childhood Foundation.



## PROJECT: «Protect your child»

#### 01.05.2018 - 30.10.2018

**GOAL**: to increase public awareness about identifying signs of bullying amongst children and legal methods of counteraction to bullying.

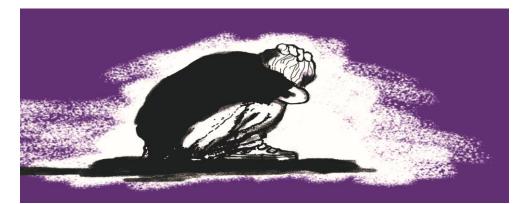


311 children, whose parents called on the hot-line, were protected from bullying.

## **PROJECT: «Equality as a Manifestation of Democracy»**

#### 01.08.2018 - 25.12.2018

**GOAL**: to promote a stable public opinion on the need to respect women's rights and promote gender equality.

#### **PARTNERS**:

LLC «Magnolia-TV», TV-channel «ChP.INFO»

The project was implemented with the financial support of the Ukrainian Women's Fund.





**RESULT**: at least 600,000 Ukrainian citizens have deepened their understanding of the need to respect women's rights and promote gender equality.

## **Co-applicant in the Kharkiv Human Rights Protection Group Project «Improved access to justice and protecting the rights to a fair trial for vulnerable groups in Ukraine»**

#### 15.06.2017 - 15.06.2018

#### GOAL OF THE PROJECT:

- Improved protection of vulnerable groups.
- Improved constructive cooperation between civil society and the state to protect effectively the rights of vulnerable groups.
- Strengthened capacity of civil society to influence state policy in protecting the rights of vulnerable groups.
- Information for the general public about the project findings and results.



**PARTNERS:** «Kharkiv Human Rights Protection Group», LLC «Magnolia-TV», TV-channel «ChP.INFO», radio «Magnolia». The project was implemented with the financial support of The European Commission.

An audience of at least 1,200,000 people was informed about violations of the right to justice of vulnerable groups.



## PARTICIPATION IN PUBLIC ASSOCIATIONS



As a member of the Public Union «Ukrainian Network for Children's Rights» participated in the joint project of the Network and UNICEF «Strengthening the capacity of civil society organizations to monitor children's rights in Ukraine».



As a member of the «Against Torture» Coalition informed the general public about cases of torture and ill-treatment in Ukraine and about the Coalition activities. In 2018, together with the Coalition members, a second series of 20 video programs «Against Torture!» was created. In each issue, 3-4 cases of torture or ill-treatment of people were highlighted. In addition, an expert assessment of the situation from an authoritative human rights defender was provided in each video release. Each video was broadcasted on TV and social networks. The target audience of each issue was 1,200,000 Ukrainian citizens.



On October 24, 2018, Ms. Heidi De Pauw, Vice-President of Missing Children Europe visited us during her monitoring visit.

On November 12, 2018, «Magnolia» NGO became a full member of the International Federation «Missing Children Europe» from Ukraine. This decision was made at the General Assembly Meeting, Brussels. Participated in initiatives of Missing Children Europe.





## **INSTITUTIONAL DEVELOPMENT**

The «Magnolia» NGO team continued to improve their knowledge and gain new experience.

A course of facilitative sessions and consultations for the Expert Assessment of Organizational Capacity (OSA) and Change Management was completed.



The recommendations of Missing Children Europe federation for development of internal guidelines for 116 000 hot-line consultants for missing children were analyzed.



The approaches to external communication were defined:

- Report on the state of development of critical areas of organizational development was drafted
- Organizational development plan was drafted
- Communication strategy was developed

## **INSTITUTIONAL DEVELOPMENT**

#### New policies and procedures were introduced:

- «Regulations on Volunteer Activities»
- «Provisions on Discrimination Prohibition at the Workplace»

Greek colleagues form public organizations shared their experience during the study visit to Greece.





A series of financial trainings «The School of Survival» was completed. Organizer: The Initiative Center to Support Social Action «Ednannia».

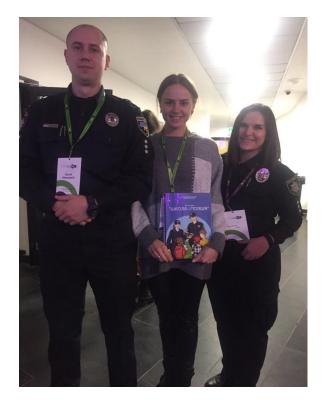
### **INSTITUTIONAL DEVELOPMENT**

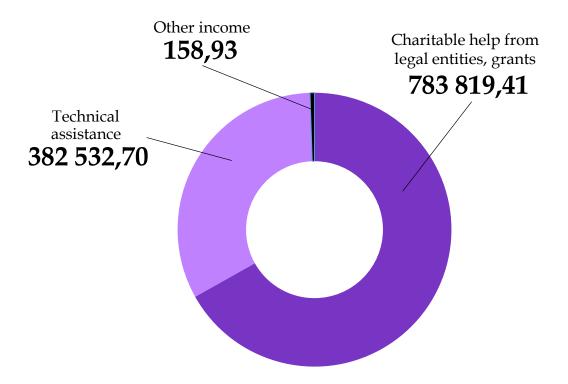

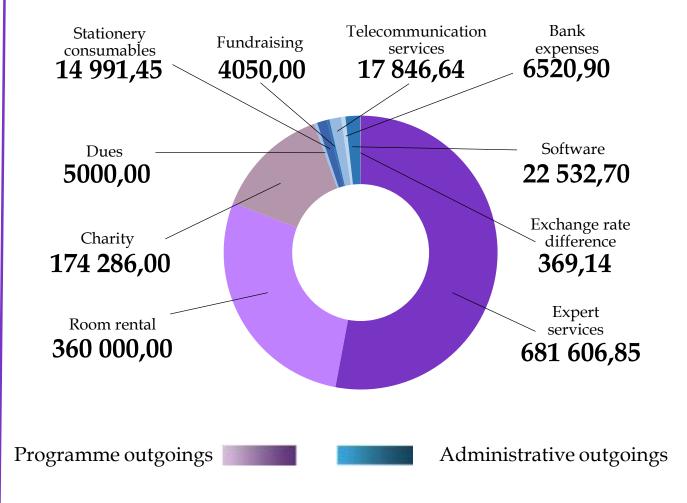
